FUNCTIONS AT WOODLANDS GOLF CLUB

Established in July 1913 on 150 acres of land, belonging to the Mayfield Estate of Count Fonceca, Woodlands Golf Club (originally Mordialloc Golf Club) has become one of the leading Sandbelt Clubs in Melbourne.

Set in manicured gardens, the Clubhouse was built in 1927 and has been enlarged and modernized with time, retaining its original charm and atmosphere.

On a fine day you may choose to have drinks served in the outdoor entertainment area but most usually guests congregate in the Woodlands Room to enjoy the beauty of the gardens and the sunset over the 18th Green.

The dining room comfortably seats 140 people and again overlooks the 1st fairway. We can accommodate up to 240 guests by combining function rooms. Your party will be treated to the finest cuisine, in spacious air conditioned comfort, served by our professional waiting staff.

All the staff at Woodlands are here to make your day extra special and will happily organize anything you require.



Corporate golf is played on Tuesday's and Friday's with either morning or afternoon play available to suit the clients needs.

Numbers under 60 will be allocated a 2 tee start; all numbers over 60 will be a shotgun start with play from holes allocated by the club. The course will still be open to members on days where the number of participants is below 100.

The event of the day will generally be an Ambrose competition with Par or Stableford an option for players with registered handicaps.

TERMS AND CONDITIONS

- Anticipated final numbers are required 14 days prior to a function date. Final numbers are required 7 days prior to your event, together with full payment. This number will represent the minimum number of guests for which you will be charged. Payment by cheque, cash or credit card (please note we do not accept Diners Club or American Express).
- Final numbers for the golfing portion required no later than 2 days prior to the event. Numbers quoted are then charged for accordingly.
- A minimum deposit of \$1000 is required at the time of confirmation. In the case of a cancellation or a significant reduction from the numbers advised as the anticipated final numbers the deposit shall be forfeited.
- Organisers are financially responsible for any damage sustained to the premises during the function.
- Organisers are responsible for ensuring any companies (other than Woodlands Golf Club) used during the event (eg. Photographers, etc) have all current and required insurances.
- Woodlands Golf Club does not accept any responsibility to/loss of property on its premises. Organisers should arrange their own insurance and security.

GENERAL INFORMATION

- It is required that the organizer will conduct the function in an orderly manner in compliance with Woodlands Golf Club Articles and by-laws.
- No food or beverages of any kind will be permitted to be brought in for consumption at the function by the organiser or any of the organisers guests without prior approval of the Club.
